

Memorandum of Understanding

This Memorandum of Understanding (MoU) is drawn on the 23rd day of August, 2021

at

BETWEEN

Marathwada Mitramandal's College of Architecture, Maharashtra, (hereinafter referred to as "MMCOA"), of the FIRST PART represented by Dr. Ujjwala Palsuley,
(Principal, MMCOA)

..... and

AND

SWaCH Plus Seva Sahakari Sanstha Maryadit (hereinafter referred to as "SWaCH Plus"), an autonomous Cooperative Society duly registered under the Maharashtra Cooperative Societies Act, 1960 on 18/10/2012 (Reg. No. PNA/DDRCT /GNL/(O)/139/12 - 13), having its office at Flat No.1, Building No.1, Jagdish Nagar, Behind Kasturba Vasahat, Ganesh Khind Road, Aundh, Pune 411007 of the SECOND PART, represented by Priya R. Kathuria and Amogh Bhongale
MMCOA and SWaCH Plus are individually referred to as "Party" and collectively as the "Parties".

WHEREAS

- SWaCH Plus, on 8th September 2021, has proposed for **'Monthly Awareness Sessions & activities'** related to waste management (the Project), which will both serve as a "proof of concept" and also help in taking participants through different kinds of waste issues and existing solutions that attempt to overcome them. SWaCH Plus to engage on a monthly basis with different topics related to waste management through them.
- In pursuance of the aforementioned, the Parties hereto wish to record under this Memorandum of Understanding (MoU), the terms of their mutual understanding in order to implement "Awareness Sessions and Activities for Waste Management".

NOW THEREFORE THE PARTIES HERETO AGREE AS UNDER:



1. Roles and Responsibilities of SWaCH Plus

1. SWaCH Plus will conduct maximum 12 online awareness sessions annually or as per mutual understanding with MMCOA to connect more individuals to a larger goal of socially inclusive, pro-environment and sustainably clean Pune.
2. The sessions, in the light of Covid-19 pandemic, would be conducted online.
3. Participants would also be encouraged to discuss current challenges and ideate to develop solutions for future.
4. Topics for these sessions may cover subjects and other such subjects as mentioned below.

Basics of Household Waste Management: How Pune manages its waste, How an individual citizen can manage one's own waste sustainably. Know your waste to manage it better!

Red Dot Campaign: A mark of health, dignity and recycling! An awareness session on Sanitary waste and Menstrual Health

SWaCH V Collect : Implementing 3R principle with citizens of Pune!

Plastic Waste: Problems of Sachet Economy, EPR and MLP (Multilayered Plastics)

RecyCole : Implementing India's first Thermocole Recycling Initiative in Pune.

5. SWaCH Plus would also inform and encourage the students, staff and faculty of MMCOA to participate in outdoor activities and other such activities as mentioned below

Waste Trail: Experiencing the journey of waste through the lenses of waste pickers.

Volunteering with SWaCH: Participation of Students of MMCOA in various initiatives of SWaCH like V Collect, National Cleanliness Day, Dasara and Diwali De-Clutter drives etc.

Challenges: Attempting to solve waste related issues through design and research challenges for students.



2. Roles and Responsibilities of MMCOA

1. MMCOA would decide the date and time of each monthly session at least a week in advance.
2. MMCOA would ensure maximum participation of students, staff and faculty of MMCOA in the online sessions.
3. Remuneration of INR 2,000 only for each awareness session is to be paid within five days after the session. In case guest speakers are invited to conduct sessions, honorarium, mutually agreed upon, is to be borne by MMCOA.
4. Administration and Transport cost incurred for outdoor activities would be borne by MMCOA.
5. MMCOA would ensure maximum participation of students, staff and faculty of MMCOA in mutually agreed upon outdoor and volunteering activities of SWaCH Plus
6. MMCOA would support SWaCH plus in providing temporary space(s) inside the campus during outdoor activities, especially like V Collect and Diwali DeClutter drives.

3. Project Implementation Support

Online platforms like Google Meet, Zoom etc. are to be decided and joining links are to be shared by MMCOA for awareness sessions.

Internal communication and promotion for awareness sessions is to be undertaken by MMCOA for maximum participation.

4. Project duration

4.1 Project validity period

The project shall commence on the date of signing the agreement and shall be valid thereafter for a period of 12 months.

4.2 Project extension

MMCOA reserves to right to change, increase or decrease the project area, timelines or modify the dates or other terms and scope assigned under this MoU. Under such circumstances, a supplementary document to this MoU shall be added covering the terms and conditions mutually agreed by both parties.
